A Message from the Executive Director, Gerald Starr

Our Annual report for 2107 noted that there were two exciting goals either achieved or in motion! We are now well established as West Side Family Health Care a federally Certified Rural Health Clinic! The second goal of expansion of our current Clinic space by the addition of 12,810 square feet of clinical space is now in the construction phase. Site development for a modern Clinic with 9 examination and 3 treatment rooms began on August 14, 2018. The \$9.2 million dollar facility project is expected to be complete in May of 2019. A new goal has now been set by the Board of Directors to establish dental services in the existing Clinic when the new Medical Clinic space is operational. The Board continues to be involved in meeting the challenges of providing outpatient healthcare in a rural setting. The Board continues to set goals for the future of the District's services to the patients, families and citizens of the West Side Health Care District. We will continue to seek to provide health services--at the highest possible level of care and at a sustainable cost to the tax payers of the District.

In all of our change---Clinic structure, training, planning and new programs—I continue to acknowledge the commitment and dedication of our Clinic staff: The physicians, nurse practitioners and their Clinic support team members continue to do a tremendous job!

Patient healthcare is our Mission and the leadership of Board of Directors and the hard work behind the scenes of the District Office staff continue to make that Mission Work possible. We appreciate the support of the citizens of the communities of the West Side Health Care District. We will continue to earn the trust and respect of our patients and their families.

A message from the Medical Director, Ronald J. Ostrom, D.O.

In July of this year I became the Medical Director for the West Side Health Care District and therefore, the Medical Director of West Side Family Health Care a federally certified Rural Health Clinic. As an experienced physician in Emergency Medicine, pre-hospital Emergency Services (EMS) and with continuing experience in outpatient care I have exciting oversight of the District's objective to offer the best possible primary care services as well as our continuing service for walk-in, urgent patients.

A review of some previous achievements and setting some new goals is appropriate. We must continue to effectively achieve our mission of improving health outcomes. We recognize that there will be times when the need for walk-in or urgent care services will be necessary. We will continue to offer that service. However, to meet the District's health care mission goal of health and wellness; we must emphasize primary care and the assessment of the patient's health status. With the patient, we will focus on lifestyle issues and the setting of personal patient goals to maintain health and prevent illness.

We continue with our focus on younger patients and will expand our primary care to adults and seniors. We have implemented the comprehensive vaccine program of Vaccines for Children (VFC) for eligible patients. We will continue with our goal to become a CHDP provider. With the completion of our Clinic expansion in May of 2019 we will have the space to provide additional primary care services and some specialty clinics on a scheduled basis.

Quality of care is the successful measure for the patient, the family and the health care organization. Quality means offering a positive patient experience while practicing the latest evidence-based medical management. As of this writing we have stabilized our provider staff with two Board Certified physicians scheduled full-time and a consistent rotation of physicians to enable our expanded hours of service 7 days a week, every day of the year. We have two Family Nurse Practitioners available in the Clinic providing exceptional care to patients of all ages. We continue with the Quality Assurance Performance Improvement (QAPI) Committee meeting on a bi-monthly basis. This QAPI committee is tasked to review all clinical processes to ensure compliance with the clinic's policies/procedures and national quality standards.

We continue with our partnership with the tele-medicine company, Telehealthdocs, in an effort to bring specialty care to the community. The Psychiatry clinic is scheduled on a routine basis as well as Endocrinology. Other potential specialties are Infectious Disease, Cardiology, and Dermatology. We feel that tele-medicine will provide timely specialty care and also overcome the transportation difficulty patients in rural areas face as they are often required to commute long distances to see specialists.

West Side Family Health Care will continue to improve and expand our services to the patient of the Westside communities. Our goal continues to be regarded as **the leader** in health care for West Kern County.

Our History

The West Side Hospital District was created in 1947 and operated the West Side District Hospital in Taft from 1952 until 1998. The District sold the Hospital to Catholic Healthcare West (CHW) in 1998. In 2003 CHW closed the Mercy Westside Hospital. In another location the District opened a small urgent care clinic in 2004.

On December 22, 2008, the District purchased the closed Hospital property from CHW which included a separate outpatient clinic. The District initiated some renovations and modifications and the facility opened in March of 2010 as West Side Urgent Care. The expanded Urgent Care included Digital radiology and Clinical Laboratory services.

In 2015 the District Board made the strategic decision to address the need for improved/enhanced access to primary care for the citizens and communities of the West Side Health Care District. A plan was set in motion to convert the Urgent Care Clinic to a federally certified Rural Health Clinic. That goal was achieved with CMS certification of the West Side Family Health Care Clinic effective January 12, 2017.

Two full-time Board Certified primary care physician are the core of our medical staff along with a stable schedule of per diem physicians which enables the expanded access to daily health services 365 days a year. We offer two excellent mid-level Nurse Practitioners for 50% or more of our Clinic operating hours. We continue our telemedicine services. The Clinic is a provider for the Vaccine for Children (VFC) and will become a provider for the Children's Health and Development Program (CHDP).

The District has begun construction of a \$9,000,000 Outpatient Clinic expansion project of approximately 12,800 square feet. The new space will include additional treatment space(s) and separate adult and pediatric clinics plus operational support space. The project anticipates a \$5,300,000 equity contribution by the District and a \$4,000,000 grant from an anonymous donor. The West Side Health Care Foundation is active in supporting the grant and additional fund raising directly through the Foundation Board's fund raising activities.



District Tax Revenues: The District receives much of its financial support from parcel taxes. These funds are used to support operations and meet required debt service agreements. They are classified as non-operating revenue as the revenue is not directly linked to patient care. Parcel taxes are levied by the County on the District's behalf during the year, and are intended to help finance the District's activities during the same year. The County has established certain dates to levy, lien, mail bills, and receive payments from property owners during the year. Parcel taxes are considered delinquent on the day following each payment due date.
